# **Analysis of the Entrepreneurial Environment** in Hunedoara County

### Abstract

This paper aims to contribute to the development of the entrepreneurial environment in Hunedoara County, presenting an updated overview related to this area of the economic field during the last ten years available on the data source: 2013-2022 for sub-chapter 4.1 and 2012-2021 for sub-chapter 4.2. First of all, in 2022 in Hunedoara County were registered and active a number of 19,111 private individuals and 9,026 legal entities. The total number of active companies increase of 36% from 2013 to 2012 and the total number of private individuals and legal entities new registered during every year analyzed registered a decrease of 1.2% from 2013 to 2022.

### 1. Introduction

Considering the last events that affected the global economy and business environment (economic crisis, the COVID-19 pandemic, armed conflicts between countries) it is important to monitor indicators related to evolution of entrepreneurship in Hunedoara County. (Doaca and Siriteanu, 2023)

Entrepreneurial environment it is a factor that influences quantity and quality of entrepreneurial activity in an economy. In order to create favorable conditions where individuals and groups of individuals to be able to carry on their entrepreneurial efforts, policy makers need to know the absolute as well as comparative strengths and weaknesses. (Holienka, 2023)

The Western Development Region is located in the western part of Romania, on the border with Hungary and Serbia, being made up of four counties (from the

administrative and territorial point of view): Arad, Caras-Severin, Hunedoara and Timiş. Starting from a set of favorable circumstances and building on an impressive industrial tradition, the region registered a steady growth, higher to the Romanian average and has managed to attract a large volume of foreign investments, oriented to various sectors. (Muntean, et al., 2023)

### 2. Methodology

Following the purpose of this research: to analyze the entrepreneurial environment in Hunedoara County, a lot of indicators from the National Trade Register Office and National Institute of Statistics (NIS) was presented in this research papers, after a large documentation about the subject.

In this research were used a series of indicators (secondary data) like: the total number of legal and private individuals registered and active; the number of incorporations of private individuals and legal entities among each year; the density of active private individuals, legal entities and total number of companies; annual entrepreneurial development rate and the configuration of entrepreneurship on its activities of the national economy in Hunedoara County. The indicators related to the evolution of entrepreneurial environment in Hunedoara County were analyzed in trend referring to the 2013-2022 period, last 10 years of reference.

### 3. Findings

### 3.1 The evolution of entrepreneurship

# 3.1.1 The total number of active private individuals and legal entities registered and active between January 1, 2013 - January 1, 2022

From the legal point of view, companies registered in the Trade Register that have not declared the suspension of their activity and are not in any of the states that can lead to the loss of legal personality are considered active. From the total number of companies registered in the Trade Register, companies with temporary suspension of activity, branches without legal personality, deregistered companies, companies in dissolution, liquidation, judicial reorganization, bankruptcy, insolvent, etc. were excluded. (National Trade Register Office, 2023)

The PFA category included family enterprises (IF), individual enterprises (II) and authorized private individuals (PFA). These categories of traders do not have legal personality but are subject to registration in the Trade Register. (National Trade Register Office, 2023)

Legal entities are represented by commercial companies (collective company, simple limited company, joint-stock company, limited liability company (SRL) and autonomous administrations. (National Trade Register Office, 2023)



The total number of private individuals and legal entities active at the beginning of every year analyzed registered an increase from 20,651 companies in 2013 to 28,137 in 2022 (an increase of 36%). The number of private individuals increased with 16% from 2013 to 2022, while the number of legal entities increased with 48.8% among the same period.

The biggest increases can be observed from 2020 to 2021 among every group of companies when almost 1,5 thousand of companies were registered and active in 2021 vs. 2020, 1,095 of these being legal entities and 378 being private individuals.



Graphic 1. Number of natural and legal persons registered and active between January 1, 2013 - January 1, 2022

In Hunedoara County the number of active legal entities is bigger than the number of active private individuals, irrespective of the year. In 2022 the County registered with 47% more active legal entities than active private individuals.

### 3.1.2 Dynamics of the number of new registered companies in the period 2013-2022

The total number of private individuals and legal entities new registered during every year analyzed registered a decrease from 2,602 companies incorporated in 2013 to 2,570 incorporated in 2022 (a decrease of 1.2%). The number of private individuals incorporated in 2013 decreased with 58% compared with the new registered companies in 2022, while the number of new registered legal entities increased with 75% among the same years of reference.

At the level of Hunedoara County, the number of active private individuals new registered in 2013 it was bigger with 25% than the number of active legal entities new registered in the same year. In 2022 the County registered with twice as many new active legal entities than new active private individuals.

From the legal point of view, companies registered in the Trade Register that have not declared the suspension of their activity and are not in any of the states that can lead to the loss of legal personality are considered active. From the total number of companies registered in the Trade Register, companies with temporary suspension of activity, branches without legal personality, deregistered companies, companies in dissolution, liquidation, judicial reorganization, bankruptcy, insolvent, etc. were excluded. (National Trade Register Office, 2023)

### 3.1.3 Territorial density of SMEs in Hunedoara County

In 2022, a percent of 32,08% of the total number of companies from Hunedoara County it was represented by small and medium-sized enterprises (active private individuals). This sector begun to receive importance in the recent years and it is characterized by flexibility but can be easy affected by the events from the economy. (Doaca and Siriteanu, 2023)


Density of active private individuals, legal entities and total number of companies

The density was calculated by dividing the indicator total number of registered companies by the total number of inhabitants per County.

The density of registered and active private individuals presents an increase in the last years analyzed, started from 16 active companies/1,000 inhabitants in 2013 to 20 companies/1,000 inhabitants. The increase it is due to the number of new registered legal and private individuals in 2022.

The density of registered and active legal entities presents an ascendent trend from 26 companies/1,000 inhabitants in 2013 to 43 companies/1,000 inhabitants in 2022.

At the total level, the density presents a rising trend, in 2022 registered with 49% more companies per 1,000 inhabitants than in 2013.

# 3.1.4 Annual entrepreneurial development rate in the period 2018-2022 in Hunedoara County


The entrepreneurial development rate in Hunedoara County was analyzed considering the density of new registered private individuals and legal entities per 1,000 inhabitants among the period 2013-2022. The density of new registered companies was calculated by dividing the indicator total number of new registered companies among every year by the total number of inhabitants per County.

The entrepreneurial development rate of Hunedoara County is on the rise, even if there it is a gap in 2020, when the density of new registered persons it was the lowest of the entire analyzed period among each group of companies analyzed.

The density of new registered and active private individuals presents a decrease in the last year analyzed, started from 3 new companies/1,000 inhabitants in 2013 to 1 company/1,000 inhabitants in 2022.

The density of new registered legal entities presents an ascendent trend from 2 companies/1,000 inhabitants in 2013 to 4 new registered companies/1,000 inhabitants in 2022.

# 3.2 The configuration of entrepreneurship on its activities of the national economy in Hunedoara County

### 3.2.1 The total number of active local units

In this sub-chapter were included the distribution of companies by all sections of Classification of Activities in the National Economy (NACE):

Agriculture, hunting and fishing, Minning and quarrying, Manufacturing, Production and distribution of electric and thermal energy, gas and warm water and conditioning air, Water distribution; salubrity, managing of waste, decontaminate activities, Construction, Trade, Transport and storage, Hotels and restaurants, Informations and communications, Financial intermediation and assurance, Real estate transaction, Professional, scientific and technical activities, Activities of administrative and support services, Education, Health and social work, Cultural and recreative entertainment activities, Other service activities available on Tempo online data base. (NIS, 2023)



In the analyzed period, the number of companies with 0-9 employees increased with 2,170 companies (29%) while the number of companies with 10-49 employees, 5—249 employees and over 250 employees decreased with 114 (12%), 60 (30%) respectively 15(36%) companies.

Considering the dimension of companies, Hunedoara County owns a percent of 99,75% SMEs with 0-249 employees and only 0,25% big companies with over 250 employees in 2021.

Active local units, by activities of national economy at level of NACE Rev.2 Among this sub-chapter, all of the active local units were analyzed considering their distribution on every section of NACE.

Analyzing the dynamic of active local units from 2012 to 2021, can be noticed the main increases:

- 2 Education section increased its total number of local units with 161% (from 38 active local units in 2012 to 99 in 2021);
- Cultural and recreative entertainment activities registered a 110% increase in the number of companies among 2012-2021 period (88 vs. 185 companies).

The biggest decrease it was registered in case of "Production and distribution of electric and thermal energy, gas and warm water and conditioning air" (-44% from 2012 to 2021).



Analyzing the distribution of active local units per each section of NACE code in the total number of active local units from 2012 to 2021, can be noticed the main percentage contributions:

- In 2021, "Trade" owned 31% from the total number of active local units in Hunedoara County;
- In 2021, "Transport and storage" owned 10% from the total number of active local units in Hunedoara County;
- In 2021 "Construction" owned 10% from the total number of active local units in Hunedoara County.

### **Conclusions**

At the county level, the entrepreneurial environment can be defined by the following insights resulted from this paper:

- In 2022 there were with 47% more active legal entities than active private individuals (19,111 vs. 9,025).
- In 2022 the distribution of total number of companies it was represented by 68% active legal entities and 32% active private individuals.
- The number of private individuals incorporated in 2013 decreased with 58% vs. 2022, while the number of new registered legal entities increased with 75% in 2013 vs. 2022.
- The density of registered and active private individuals started from 16 active companies/1,000 inhabitants in 2013 to 20 companies/1,000

inhabitants in 2022, while the density of registered and active legal entities presents an ascendent trend from 26 companies/1,000 inhabitants in 2013 to 43 companies/1,000 inhabitants in 2022.

- Hunedoara County owns a percent of 99,75% SMEs
- The NACE section "Education" increased its total number of local units with 161% while "Cultural and recreative entertainment activities" registered a 110% increase in the number of companies among 2012-2021 period.
- In 2021, "Trade" owned 31% from the total number of active local units in Hunedoara County.

In conclusion, after the pandemic period, the entrepreneurial environment from Hunedoara County is in full growth, being represented especially by its increase on new registered companied year by year, its big number of SME'S and its big percent of companies registered on "Trade" section of NACE code.
